The College begins screening full-time applications in October each year for admission the following August.

Admissions Requirements

All prospective NDIC students must be U.S. citizens who are members of the U.S. Armed Forces or federal government employees. Additionally, students must possess an active TS/SCI security clearance. Government contractors are not eligible for enrollment.

Nominations

Nominations are required for full-time study programs, as well as the following part-time programs: BSI program at NSA, MSSI programs at the NGA and NSA Graduate Centers, the MSSI Program for Reserves and the DIA Cohort.

Individuals applying to these programs should contact their education, training, or human resource personnel to determine the nomination process for their particular organization.

Nominations must be submitted to the NDIC Admissions Office and may be written memo style on official U.S. government letterhead, on DoD Form 1556 or on US Government Standard Form 182.

Nominations are not required for individuals applying for part-time study in the Evening MSSI, the Monthly Executive MSSI or Continuing Education.

The following materials must be received by the stated deadlines to receive full admissions consideration. Please use the following checklist as you complete your application:

MSSI APPLICANTS:

- NDIC Application Form indicating program/campus to which you are applying
- Statement of Purpose (500-word **unclassified** essay — typed and double spaced) explaining:
 - o your motivation for pursuing study in intelligence
 - o your professional goals and objectives
 - o what you have achieved in your studies and/or career that will enhance your capabilities to undertake such a degree
- Official undergraduate and graduate transcripts sent from schools directly to NDIC
- Official GRE Score Report (scores must be less than 5 years old – NDIC Code 5205)
- Nomination if applying for full-time study or the following part-time programs: DIA Cohort, NGA and NSA Cohorts, and the MSSI Program for Reserves

Note: Applicants with a completed master’s or earned doctorate degree from a regionally accredited college/university are not required to submit GRE scores. Graduate transcripts must be submitted to NDIC. No other tests may be substituted for the GRE.

UNDERGRADUATE APPLICANTS:

- NDIC Application Form indicating full or part-time study
- Statement of Purpose (500-word **unclassified** essay — typed and double spaced) explaining:
 - o your motivation for pursuing study in intelligence
 - o your professional goals and objectives
 - o what you have achieved in your studies and/or career that will enhance your capabilities to undertake a degree completion program
- Nomination from parent organization
- Official High School Transcript or GED
- Official transcripts and documentation of all college credit, including as applicable:
 - Transcripts from each college attended
 - Service transcripts: Air Force (CCAF); Army (AARTS); Coast Guard (CGI); Navy/Marines (SMART)
 - Official copies of standardized test results from:
 - CLEP exams (NDIC Code 7542)
 - DSST exams (NDIC Code 9442)
 - Excelsior College exams
 - Defense Language Proficiency Tests (DLPT)
 - DoD school transcripts, Defense Language Institute, National Cryptologic School, etc.

- your motivation for undergraduate or graduate study in intelligence
- your professional goals and objectives
- what you have achieved in your studies and/or career that will enhance your capabilities to undertake study at the National Defense Intelligence College

TRANSCRIPTS

Applicants must have official transcripts of **all** post-secondary education sent directly from the educational institution(s) or testing agencies from which credit has been earned.
